2013 CAPITAL PROJECTS

PURPOSE: To request to bring forward a bylaw to appropriate \$1,551,200 from Capital

Reserves to finance fifteen projects.

RECOMMENDATION:

1. THAT a bylaw be brought down to appropriate \$1,551,200 (inclusive of 12% HST) from Capital Reserves to finance fifteen projects.

SUBJECT: BYLAW TO FUND PARKS, RECREATION & CULTURAL SERVICES

2013 CAPITAL PROJECTS

RECOMMENDATIONS:

- **1. THAT** the expenditure of \$1,385,000 from the Provisional Capital Budget for the projects outlined in this report be approved.
- **2. THAT** Council be requested to bring down a bylaw to appropriate \$1,551,200 (inclusive of 12% HST) from Capital Reserves to finance these projects.

REPORT

The 2013 Provisional Capital Budget for Parks, Recreation and Cultural Services contains the following 15 projects to be funded from Capital Reserves. To enable work to go ahead on these projects, approval is requested to bring down a bylaw for funding.

1. Burnaby Mountain Golf Course

\$145,000

Renovations and construction upgrades to sand traps, practice area, tee reconstruction, and phase 2 of this year's irrigation and drainage upgrades.

2. Swangard Stadium

90,000

Swangard track is nearing the end of its life span and requires significant repairs so it is fully functional and safe for the coming season. There is erosion under the track surface and lifting of the surface in the high jump area and on many places on the track.

3. Cash Handling Upgrades

25,000

Upgrading of cash handling necessary to implement Payment Card Industry standards for credit card processing on 33 department cash registers. Includes upgrade to software, upgrade to cash register hardware and replacement of credit card terminals.

4. Food Services Equipment Replacement

50,000

Ongoing replacement of equipment including such items as small wares, catering equipment and furniture, and beer sales equipment at various locations (Encores, Riverway, and Bonsor).

5. Field Houses and Park Entry Security

50,000

Continue the implementation of the master key system for park field houses, washrooms and park entry gates.

6. Trails and Footbridges

80,000

Replacement of various footbridges, stairways and retaining walls within the parks trail system including Kaymar stairs, Patterson marine trail and Burnaby 2000 trail.

7. Park Fencing and Support Structures

135,000

Fencing replacements and improvement to various park and playfield fences including Burnaby Lake Sports Complex-East, Bonsor Park and Ron McLean Park.

8. Cameron Park

250,000

Continued development of the park to include a water feature, passive area seating and trail works.

9. Eco Sculptures

75,000

Frame float and trailer alterations to older structures including welding and galvanization. Supply and installation of new sculptures at Riverway Golf Course.

10. Access Improvements

50,000

Accessibility upgrades in City parks to meet current day access standards. This involves park features such as surface materials, access points to parks, trails and parking lots, width of entry points and reduction of steep grades where possible. Barnet Marine Park, Fraser Foreshore and Central will be worked on in 2013.

11. Minor Equipment

75,000

Purchase of the annual allotment of small mowers, weed eaters, leaf/debris blowers, variety of power saws, small turf maintenance attachments and janitorial equipment.

12. Shadbolt Studio 211 Upgrade

200,000

Upgrades to the studio to include energy efficient double-paned windows, ceiling, HVAC, sound proofing, lighting and interior wall treatments.

13. Shadbolt – Theatre Lighting and Sound

50,000

Replace theatre lighting grid truss system, upgrade sound and lighting equipment as well as controls.

14. Burnaby Village Museum

35,000

Create a detailed design for entry signs at Carousel and main gate, fabricate/install two wayfinding signs and four interpretive signs per sign program.

15. Burnaby Village Museum

75,000

Upgrade music shop display, Elworth House wall treatments, locomotive shelter/access upgrades and heritage sign repairs.

Sufficient Capital Reserves are available to complete the above projects in the 2013 Provisional Capital Budget. It is recommended that Council be requested to bring down a bylaw to appropriate \$1,551,200 (inclusive of 12% HST) from Capital Reserves to finance these projects.
