At the conclusion of the 'Closed' meeting, the 'Open' meeting was reconvened at 7:06 p.m. in the Council Chamber.

The 'Open' Council meeting reconvened in the Council Chamber at 7:06 p.m.

MOVED BY COUNCILLOR CALENDINO: SECONDED BY COUNCILLOR JOHNSTON:

"THAT the delegations be heard."

CARRIED UNANIMOUSLY

A) Katherine Kinman, owner and operator of King Ed Pet Centre, 7377 Kingsway, Burnaby appeared before Council to oppose a ban on the sale of puppies and kittens in pet stores. The speaker noted that the King Edward Pet Centre does not sell animals from puppy or kitten mills. All the dogs and kittens sold in their store come from customers who need assistance in finding a home for their animals. The speaker further advised that the King Ed Pet Centre educates their customers regarding responsible pet ownership.

The speaker emphasized that the King Ed Pet Centre has the highest regard for the welfare of their animals. Ms. Kinman noted they are not part of the problem; they are part of the solution. In conclusion, she noted that everyone should work together to address animal welfare issues.

A copy of the delegation's presentation is on file in the Office of the City Clerk.

- B) Ms. Soroski, Vancouver Orphan Kitten Rescue (VOKRA), 2193 Charles Street, Vancouver appeared before Council to discuss the sale of small animals in pet stores. The speaker noted the following points in response to a presentation to Council on 2013 Nov. 18 by Mr. Tom Peters, owner of Pet Habitat Metrotown:
 - Mr. Peters did not approach VOKRA regarding selling their kittens at Pet Habitat.
 - Mr. Peters noted that Pet Habitat rescues kittens from a town in Quebec, however, in Mrs. Soroski's opinion, ethical rescuing would involve the spaying and neutering of the parents of those kittens.

- Pet Habitat continues to sell turtles; as many as 8-10 turtles were in the store yesterday.
- Mr. Peters advised that Pet Habitat sources pets from United States Department of Agriculture (USDA) breeding facilities; in response to this statement, Ms. Soroski provided documentation noting that the US Department of Agriculture's Office of Inspector General (OIG) released a report indicating the USDA has not been doing a good job of enforcing the bare minimum standards of care as outlined in the Animal Welfare Act.

Ms. Soroski requested that Council ban the retail sale of all live animals in pet stores. The speaker noted pet store animals are bred for profit and do not have spay or neuter certificates. In conclusion, Ms. Soroski urged the City of Burnaby to join the effort to curb pet overpopulation.

C) John Crocock, 225-13700 Mayfield Place, Richmond appeared before Council to oppose a ban on the sale of puppies and other small animals in pet stores. Mr. Crocock advised that pet stores are the "easiest place to regulate" any concerns regarding the care and treatment of animals. The speaker emphasized that a licenced pet store is the best way to ensure certain standards are being met. Mr. Crocock concluded by noting that standards and regulations for pet stores should also apply to rescue groups and other organizations.

Arising from Council's consideration of public comment on this matter, both written and oral, Council requested staff to bring forward a report addressing the advisability and feasibility of requiring the spaying and neutering of kittens, cats, and puppies that are sold in pet stores and, restricting the origin of small pets destined to be sold in local pet stores.

A) Environment Committee Re: Electric Hand Dryers <u>City Green Team Initiative</u>

The Environment Committee submitted a report seeking Council approval to undertake a retrofit project to replace paper towel dispensers in the City's field houses/washrooms with electric hand dryers.

The Environment Committee recommended:

1. THAT Council approve an expenditure of \$60,000 from the Gaming Fund for the retrofit of electric hand dryers across existing field houses/washrooms, as outlined in this report.

B) Finance and Civic Development Committee Re:Appeal for a Global Glass-Steagall

The Finance and Civic Development Committee submitted a report seeking Council support for reinstatement of Glass-Steagall legislation. Glass-Steagall legislation refers to specific provisions of the US Banking Act of 1933 in which limitations were placed on commercial bank securities activities and restrictions were imposed to limit affiliations between commercial banks and securities firms. A return to Glass-Steagall legislation for the US and introduction to the global community puts forth a foundational necessity that was identified after the Great Depression. The purpose of reinstatement is to support a stronger and more manageable banking system that protects the interest of depositors. However, additional stipulations in the petition proposed are secondary to Glass-Steagall and distinctly different, thus requiring further consideration.

The Finance and Civic Development Committee recommended:

- 1. THAT Council support the Committee for the Republic of Canada in its efforts to introduce a global provision that separates commercial bank and investment banking activities as provisioned in the US Banking Act of 1933, commonly referred to as Glass-Steagall.
- 2. THAT the Mayor on behalf of Council write a letter of support to the Committee for the Republic of Canada, P.O. Box 3011, Youville Station, Montreal, QC H2P 2Y8, in their appeal to enact global Glass-Steagall legislation.

 - c) The installation of all electrical, telephone and cable servicing, and all other wiring underground throughout the development, and to the point of connection to the existing service where sufficient facilities are available to serve the development.
 - d) The granting of a Section 219 Covenant respecting flood proofing requirements.
 - e) The provision of any necessary easements, covenants or statutory rights-

of-way.

- f) The submission of a suitable on-site stormwater management plan to the approval of the Director Engineering that meets or exceeds the guidelines established in the Glenwood Concept Plan, Rezoning Reference #99-51 and Subdivision Reference #00-73. The granting of a Section 219 Covenant and deposit of sufficient monies to guarantee the plan's provision and continued operation are required.
- g) The submission of a Site Profile and resolution of any arising requirements.
- h) The review of a detailed Sediment Control System by the Director Engineering.
- i) The submission of a geotechnical review regarding the stability of the site to accommodate the proposed development, for review by the Chief Building Inspector and granting of a Section 219 Covenant respecting the submitted report.
- j) The deposit of the applicable GVS&DD Sewerage Charge.
