**PURPOSE:** 

To set the Council meetings, Committee meetings and Public Hearing schedules

for 2014.

#### **RECOMMENDATION:**

1. THAT Council approve the Council meeting, Committee meeting and Public Hearing schedules for 2014 as set out in Appendix "A" "B" and "C" of this report.

#### REPORT

The Community Charter requires Council to adopt a schedule and give public notice of Council meetings, Committee meetings and Public Hearings in each year. This report fulfills that requirement. It is recognized that adopting this report does not preclude Council from adopting future resolutions to add, cancel or change meeting dates, times and/or venues as the year progresses.

#### 1. Council Meetings and Committee Meetings

Closed Council meetings from which the public is excluded will continue to be held at 6:30 p.m. in the Council Committee Room. During the process of scheduling Open and Closed Council meetings and Committee meetings, consideration has been given to avoid conflict with the FCM and UBCM annual conferences and the Local Government Election in 2014 November.

## 2. Public Hearings

Public Hearings proposed in this report for 2014 February, April, June, August, October, and December will deal with the most recent group of rezoning applications forwarded for consideration under the usual bi-monthly reporting schedule. The Public Hearing dates in January, March, May, July, September and November would be available for other cases such as those rezoning applications previously being processed, and if it is found unnecessary to hold a Public Hearing in these months, the scheduled hearing may be cancelled.

Council has, in the past, approved consideration of special Public Hearings for specific rezoning requests which have not corresponded to the scheduled dates. Unless otherwise directed, the Planning and Building Department will pursue consideration of similar extraordinary cases which may occur in the coming year, as required.
