Ms. Jeanne Fike, Burnaby Intercultural Planning Table (BIPT) Co-Chair, accompanied by Planning Table representatives Jan Taylor, James Gruneau, and Jody Johnson, appeared before Council to provide an overview of recent projects and initiatives for the benefit of immigrants and refugees. The BIPT has sponsored two inter-faith projects which demonstrate the value of faith in the settlement process and the importance of

including members of all faith communities in continuing dialogue. A community-based steering committee will be struck to form an action plan.

The delegation expressed concern regarding recent federal government legislative changes affecting refugees including accelerated hearing dates which provide little time for claimants to find legal counsel and prepare their case. In addition, the delegation noted health coverage for claimants has been significantly reduced.

The speakers concluded by expressing appreciation to Council for proclaiming 2013 February 08 as "Embracing Cultural Diversity Day" in the City of Burnaby.

A) Kevin Lusignan, Senior Manager of Social and Economic Inclusion, Burnaby Association of Community Inclusion (BACI), appeared before Council to discuss ways to increase employment opportunities for people with developmental disabilities.

The speaker noted BACI provides support to people with developmental disabilities and employers to create conditions for people to achieve social and economic inclusion through employment.

The speaker expressed appreciation to the City of Burnaby for being a diverse, open and disability confident employer. Mr. Lusignan also noted BACI would like to work more closely with Burnaby to implement actions in the City's Social Sustainability Strategy designed to increase disability confidence in City operations through employment, purchasing practices and influencing various business groups in the community.

The goal is to foster a strong sense of community identity, commercial viability and Urban Village redevelopment for Sixth Street, set within the larger context of southeast Burnaby.

The proposed policy seeks to facilitate the development of sufficient adaptable housing stock to meet current demand in Burnaby, to respond to Burnaby's changing demographics, to support emerging markets for 'flexible' housing, and to provide both increased and consistent housing choices for Burnaby residents of all ages and abilities.

The Community Development Committee recommended:

- 1. THAT Council endorse the proposed changes to Burnaby's Adaptable Housing Policy, as summarized in Section 5.0 of this report, as a basis for consultation with representatives of the housing development industry, persons with disabilities, and seniors.

Finance and Civic Development Committee Re: Capital Project Funding – City Buildings

The Finance and Civic Development Committee submitted a report seeking funding approval for various City facilities capital projects. The 2013 projects will include improvements at City Hall, Recreation Centres, Anderson House, Libraries and Fire Halls.

The Finance and Civic Development Committee recommended:

1. THAT Council authorize expenditures of \$2.61 Million (inclusive of HST) for Capital improvements at various City facilities, as outlined in this report.

2 THAT Council bring down a Capital Reserves Bylaw in the amount of \$2.21 Million (inclusive of HST) to finance various City facilities capital projects.

Diversification and a conservative investment strategy have provided the City with a 2012 return of \$37.7 million and an annual yield of 5.00% on the City's investment portfolio. For 2013, Treasury will continue to monitor money and fixed income markets for investment opportunities to provide liquidity, capital preservation and yield management.

The Finance and Civic Development Committee recommended:

J) Finance and Civic Development Committee Re: Payment Card Industry Data Security Standards (PCI-DSS) Project

The Finance and Civic Development Committee submitted a report seeking funding approval in the amount of \$65,000 from stabilization reserve for the initial phase of the City's Payment Card Industry Data Security Standard (PCI-DSS) project. PCI-DSS standards were introduced in 2006 to reduce merchant fraud for businesses and organizations that provide credit and debit card payment acceptance services to their clients. The City is required to meet these standards to achieve annual certification.

The Finance and Civic Development Committee recommended:

1. THAT Council approve funding in the amount of \$65,000 from the Stabilization Reserve to begin the process of Payment Card Industry Data Security Standards Certification, as outlined in this report.

1. <u>E-COMM Police Dispatch Service</u>

The City Manager submitted a report from the Deputy City Manager seeking Council approval to enter into a service agreement with E-COMM for police dispatch service in Burnaby. Discussions with E-COMM in the past several months have led to the conclusion that E-COMM can provide a cost efficient and operational effective business model to Burnaby. In addition to the enhanced security and larger work force benefits to E-COMM operations, its service package will offer cost savings (operating and capital improvements) to the City.

The City Manager recommended:

1. THAT Council approve the use of E-COMM for police dispatch service in Burnaby and staff be authorized to enter into a service agreement based on the terms and conditions outlined in this report.

The estimated cost total is \$392,000 including HST of \$42,000. The final payment will be based on actual quantities ordered and current unit prices.
