MOVED BY COUNCILLOR CALENDINO: SECONDED BY COUNCILLOR JORDAN:

"THAT the delegations be heard."

CARRIED UNANIMOUSLY

A) Ron Corbeil, Health, Safety & Environmental Coordinator of the United Steel, Paper and Forestry, Rubber, Manufacturing, Energy, Allied Industrial and Service Workers International Union, appeared before Council to discuss the Union's campaign to ensure the enforcement of the Westray Criminal Code amendments which have been put in place to deal with workplace death and injury.

The speaker showed two short videos noting that more than 1,000 Canadian workers each year are killed at work, and the Westray amendments that hold corporations criminally accountable for the health and safety of workers are not being utilized.

In conclusion, Mr. Corbeil requested that Council endorse the following resolution:

"WHEREAS it has been more than two decades since the Westray mine disaster in Nova Scotia and a decade since amendments were made to the Criminal Code of Canada to hold corporations, their directors and executives criminally accountable for the health and safety of workers; and

WHEREAS police and prosecutors are not utilizing the Westray amendments, and not investigating workplace fatalities through the lens of criminal accountability; and

WHEREAS more than 1,000 workers a year are killed at work;

THEREFORE BE IT RESOLVED that this Council support a campaign to urge our provincial/territorial government, specifically the Attorney-General and Labour Minister, to ensure that:

- Crown attorneys are educated, trained and directed to apply the Westray amendments:
- dedicated prosecutors are given the responsibility for health and safety fatalities;
- police are educated, trained and directed to apply the Westray amendments;
- there is greater coordination among regulators, police and Crowns so that health and safety regulators are trained to reach out to police when there is a possibility that Westray amendment charges are warranted."

Arising from discussion, Councillor Johnston was granted leave by Council to introduce the following motion:

"THAT the delegation's submission including the resolution be **REFERRED** to the Executive Committee of Council for reveiw."

B) Councillor Bill Harper and Mark Allison, Manager, Strategic Initiatives and Sustainability, City of New Westminster, appeared before Council to present their position on the Pattullo Bridge Replacement Project.

Councillor Harper noted that following the recent Provincial announcement on new directions for transportation funding and governance in the Lower Mainland, the Pattullo Bridge Review community consultation on remaining options has been postponed and the TransLink Mayors Council has been asked to prepare a 30-year investment plan for the region. As the future of the Pattullo Bridge will have a high priority in this plan, the City of New Westminster considers it important that all community, regional and provincial stakeholders are aware of the City's position.

Councillor Harper advised that current use of the Pattullo Bridge as "the free alternative" to the recently tolled Port Mann Bridge is significantly affecting the livability of New Westminster. The introduction of tolls on the Port Mann Bridge has led to a significant increase of traffic, including truck traffic, over the Pattullo Bridge, on major arterial and local streets, as drivers seek to find faster ways to avoid congestion. Traffic on the bridge has increased by 6,000 trips per day with a 75% growth in truck traffic on Royal Avenue alone.

The speaker noted that several options for the Pattullo Bridge were considered, but given the City's established historic and dense urban context, it is the City's view that a new tolled 4-lane bridge, built to urban arterial standards and incorporating pedestrian and cycling facilities, would meet all of the City's and the region's needs. Tolls on a 4-lane bridge are essential not only to finance the new bridge, but also as an integral measure to lower demand for car travel over the bridge, and in effect, promote the use of alternative transportation modes.

Councillor Harper further advised the City of New Westminster is strongly supportive of re-allocating capital cost savings resulting from limiting a new bridge to four lanes toward much needed rapid transit projects addressing the needs of the region.

Councillor Harper noted the City of New Westminster adopted the following resolution regarding the Pattullo Bridge replacement project:

"WHEREAS TransLink has identified the need to rehabilitate or replace the Pattullo Bridge in order to respond to risks related to its vulnerability in an earthquake, its structural integrity and the effect of river currents on its foundations;

WHEREAS TransLink, the Cities of New Westminster, Surrey and Coquitlam have been participating in the Pattullo Bridge Strategic Review process;

WHEREAS the Province has asked the TransLink Mayors' Council to prepare a fully-costed, fully-funded transportation vision and has made a commitment of Provincial funding for major rapid transit projects and the Pattullo Bridge replacement;

AND WHEREAS the Pattullo Bridge is one of the key priorities for the region;

THEREFORE BE IT RESOLVED

THAT New Westminster's position is that the Pattullo Bridge Strategic Review process does not support the provision of increased capacity on the Pattullo Bridge and that a new, tolled 4-lane option, built to urban arterial standards and incorporating excellent pedestrian and cycling facilities, best addresses the Strategic Review's problem statement and satisfies the City's and the region's objectives;

THAT for efficient regional goods movement, a direct connection be made linking the South Fraser Perimeter Road with the Port Mann Bridge, thereby optimizing existing and newly constructed transportation corridors, and shifting regional truck traffic to corridors where significant investments have already been made and where adequate capacity is available;

AND THAT New Westminster supports the reallocation of the capital cost savings of a new tolled 4-lane Pattullo Bridge to other much needed rapid transit projects that better address the needs of the region."

The speaker concluded by requesting that the City of Burnaby endorse the City of New Westminster position regarding the bridge.

His Worship, Mayor Derek Corrigan advised that the delegation's presentation will be forwarded to staff as they are currently working on a report regarding the Pattullo Bridge replacement project for the consideration of Council.

Re: Radio Frequency Identification Conversion Project – Bob Prittie Metrotown and McGill Branches, Burnaby Public Library (Phase 1)

The Finance and Civic Development Committee submitted a report seeking Council approval to appropriate \$400,000 from the 2014 Provisional Budget for the purchase of equipment and supplies required for the conversion to Radio Frequency Identification for securing and circulating library materials. The move to RFID and self-check at the Bob

Prittie Metrotown and McGill Branches will create barrier-free and more open entrances as well as a reduction in repetitive tasks and the consolidation of circulation functions for a more efficient use of staff.

The Finance and Civic Development Committee recommended:

- 1. THAT Council approve the expenditure of \$400,000 from the 2014 Provisional Budget for the purchase of the equipment and supplies required for the conversion to Radio Frequency Identification for securing and circulating library materials.
