The 'Open' Council meeting was called to order in the Council Chamber at 7:03 p.m.

PRESENTATION

Mayor Corrigan presented banners to Amelia Kathleen, artist, and Garth Errico, Principal of Burnaby Central Secondary School, Andy Chin, Principal of Burnaby Mountain Secondary School for the artwork created by Yejin, and to Maria Perez, Principal of Cameron Elementary School for the artwork created by Alana.

A) Mr. Terry MacDonald, 4863 Brentlawn Drive, Burnaby appeared before Council to discuss the Brentwood traffic system. Mr. MacDonald provided a historical chronology of events regarding the Brentwood Town Centre Community Plan and also reviewed the Burnaby Transportation Plan in relation to the subject area.

Mr. MacDonald advised that a report to Council in 1975 proposed that the internal traffic systems for the multiple-family development Community Plan area and the existing single-family dwelling area to the north be separated from each other.

The speaker concluded by urging Council to consider the following requests:

- That the internal traffic systems for the existing and future multi-family dwelling areas within the Community Plan area (Gilmore to Holdom) be separated from the single-family dwelling areas to the north.
- That the classification of Beta Avenue between Lougheed Highway and Brentlawn Drive as a Local Collector Street be removed.
- That a traffic system be designed at the Brentwood Drive/Brentwood Mall/Beta Avenue intersection to prevent access to and from Ridgelawn Drive and Brentlawn Drive.
- That a traffic system be designed at the Brentwood Mall North Entrance at Beta Avenue to prevent access to and from Ridgelawn Drive and Brentlawn Drive.
- That the classification of Brentlawn Drive as a Local Collector Street be removed.
- That Midlawn Drive be classified as the Local Collector Street for the Brentwood Park Subdivision and that the record show any full traffic signal to be installed on Willingdon Avenue between Parker Street and Brentlawn Drive will be installed at the Midlawn Drive intersection when Willingdon Avenue is widened.
- That a traffic system be designed for all residential streets in the Brentwood Park Subdivision to reduce the through traffic by 90% (and please add "One-Way Streets" to the "Traffic Calming/Control Measures" listed on page 90 of the Transportation Plan).
- That the streets in the single-family residential Community Plan Area within 500m north of the apartment, retail and office developments be designated Residential Parking Only, similar to the arrangements in place for RPO parking on other streets in the City.

A) Deputy City Clerk Re:Petition Results – Hastings Street BIA

The Deputy City Clerk submitted a report providing Council with petition results for the Hasting Street Business Improvement Area (BIA). In order for a petition against the Hastings Street BIA to be deemed sufficient, it must be signed by the owners of at least 50% of the parcels in the BIA area and those parcels must represent at least 50% of the assessed value of land and improvements that would be subject to the BIA levy. In this

case, the owners of 23 of the 196 parcels (11.8%) petitioned against the BIA and those parcels represented 18.6% of the assessed value of land and improvements.

Accordingly, staff advised the petition against the BIA is deemed insufficient and Council may, therefore, proceed with the Hastings Street BIA.

The Deputy City Clerk recommended:

1. THAT Council receive the petition results covering the Business Improvement Area (BIA) for the Hastings Street Area.

3. Contract Award 2014-13 Watermain Replacement and Road Rehabilitation Program – Package B

The work of this contract involves the construction of new ductile iron watermains and road rehabilitation on six different streets. The work also includes approximately 2,800 lineal metres of watermain, 27,000 square metres of asphalt milling and 6,700 tonnes of asphalt.

The work of this contract involves the installation of catch basins and leads, removal of existing concrete slab, curb, gutter and sidewalk, asphaltic cold milling and machine laid asphaltic concrete, as well as electrical works including re-signalization and streetlights at the Kingsway/Imperial intersection, traffic signal modifications at the Kingsway/McPherson intersection and optional street light modifications at the Kingsway/Royal Oak intersection.

THAT Council approve a construction contract be awarded to the lowest bidder Imperial Paving Limited for a total cost of \$1,118,737.29 including GST in the amount of \$53,273.21 for work as outlined in this report. Final payment will be based on actual quantity of goods and services delivered and unit prices as tendered.

Rezoning Reference #12-45 for a 53 storey residential apartment building at 4567 Lougheed Highway.

The report addressed matters related to public consultation; density and height; traffic, parking and transit; accessibility; emergency access; potential environmental impacts; infrastructure capacity; cycling and pedestrian infrastructure; and available park and school space. As a condition of Final Adoption of the rezoning, the developer will be required to complete the required prerequisites of the subject rezoning application, as well as obtain the necessary City approvals and permits, which will ensure that matters reviewed at Public Hearing are appropriately addressed.

Councillor Dhaliwal expressed concern regarding Bill 24, the Agricultural Land Commission (ALC) Amendment Act.

Arising from discussion, Councillor Dhaliwal was granted leave by Council to introduce the following motion:

MOVED BY COUNCILLOR DHALIWAL: SECONDED BY COUNCILLOR JOHNSTON:

"WHEREAS the Agricultural Land Reserve was created as a provincial zone for the purpose of preserving agricultural land throughout the province and provided for technically based decision making about inclusions and exclusions in the reserve;

WHEREAS Bill 24, introduced by the government in the provincial legislature removes those protections by substituting political decision making for independent reviews, by allowing development on 90 percent of the land in the reserve and allowing the Minister to set the goals for the reserve;

WHEREAS the Provincial Government has, without consultation with the public or with local governments created two zones for the Agricultural Land Reserve in the Province of BC thereby discriminating between regions and potentially constraining their ability to achieve and sustain agricultural self-sufficiency and economic development; and

THEREFORE be it resolved that the LMLGA send a letter to the Union of BC Municipalities, Minister of Agriculture Norm Letnick, Minister of Community, Sport and Cultural Development, Coralee Oakes, Premier Christy Clark, the Leader of the Official Opposition with copies to all BC local governments, stating our opposition to the proposed alteration to the Agriculture Land Reserve."

Council requested this resolution be submitted to the 2014 LMLGA Annual Meeting. Council acknowledged the deadline for submission of resolutions has passed. Council noted, however, this resolution should be considered as an emergency resolution as this matter is currently before the provincial legislature.

Council also requested that a copy of this resolution be forwarded to UBCM member municipalities.

Councillor McDonell

Councillor McDonell advised that His Worship, Mayor Derek Corrigan was the guest artist at L'Arche Greater Vancouver's fifth annual Art of Being Together event at Nikkei Centre on 2014 April 3. Councillor McDonell further noted that he auctioned off the Mayor's artwork for \$2,000 with the proceeds going to support the work of L'Arche in the community.
