- A) Walter Hallam, 3321 Dalebright Drive, Burnaby appeared before Council expressing concern regarding the lack of opposition party representation on Burnaby City Council. To address this matter, the speaker proposed term limits for the Mayor and Councillors. He also proposed that the Mayor and four Councillors continue to be elected City wide while each of the remaining four Councillors be elected to represent one of the four town centres in the City similar to a ward system form of government.
- **B) Jake Fiddick**, 4372 Greta Street, Burnaby and **Ajay Sehgal**, 4361 Greta Street, Burnaby appeared before Council expressing concern regarding the cutting down of boulevard trees in the 4300 block of Greta Street.

The delegation requested the City recognize that the residents of the 4300 block of Greta Street previously signed a petition (over 50 years ago) for the equivalent of the "standard road works LASP which includes the installation of boulevard trees".

The delegation also noted the following points:

- three or four boulevard trees removed at 4329 Greta Street should be replaced.
- boulevard trees at 4322, 4346 and 4362 Greta Street should be saved as redevelopment takes place.

The Environment Committee submitted a report seeking Council approval of the program for World Rivers Day 2014 at the Burnaby Village Museum, as well as expenditure authorization for advertising and promotion. The 10th Annual World Rivers Day celebration is scheduled for Sunday, September 28, 2014 at the Burnaby Village Museum, from 11:00 a.m. to 4:30 p.m. The proposed program includes an opening ceremony, live music, activities for children, environmental education displays and activities, City of Burnaby displays and demonstration riparian planting.

Re: Draft Eagle Creek Integrated Stormwater Management Plan

The Environment Committee submitted a report providing Council with an overview of the principles, elements and recommendations of the draft integrated stormwater management plan for Eagle Creek watershed in North Burnaby. The plan sets out how the resources within the watershed should be managed to balance land development, stormwater management with environmental protection, preservation and enhancement.

Re: Invasive Plant Management in Burnaby Parks

The Environment Committee submitted a report presenting Council with the results of the 2013 invasive plant management program and outlining the next steps for implementation. The Committee advised the 2013 summary of invasive species management show positive results. The Knotweed stem injection has proven effective; however the ability to treat larger stands of Knotweed is impractical. A foliar spray application has been proven by the Ministry of the Environment and others to be most effective on larger stands of Knotweed. The Committee requested Council approve the use of foliar spray to manage Knotweed for the 2014 and 2015 season.

The Environment Committee recommended:
