#### SUBJECT: 2014 ELECTION BYLAWS AND ELECTION DAY PAY RATES

**PURPOSE:** To obtain Council authorization to prepare bylaws for conducting the Advance Voting Opportunities and Special Voting Opportunities for the 2014 Local Government Election, to establish election day pay rates and to enter into an agreement with School District No. 41 regarding cost sharing.

#### **RECOMMENDATIONS:**

- **1. THAT** Council authorize Bylaw No.12948 dividing the City into voting divisions be repealed.
- **2. THAT** Council authorize the City Solicitor to prepare a bylaw to provide additional Advance Voting Opportunities on 2014 November 01 and 08.
- **3. THAT** Council authorize the City Solicitor to prepare a bylaw to provide Special Voting Opportunities for qualified residents of care homes and seniors facilities on 2014 November 04 and for qualified residents hospitalized in Burnaby Hospital on general voting day, 2014 November 15 as presented in the *attached* Appendix "B".
- **4. THAT** Council approve the 2014 Election Day pay rates as presented in the *attached* Appendix "C".
- **5. THAT** Council authorize the Chief Election Officer to execute an agreement with School District No. 41 to share in the costs of the 2014 Local Government Election for School Trustees.
- 6. THAT a copy of this report be forwarded to School District No. 41 for information.

#### REPORT

#### 1.0 Introduction

The *Local Government Act* requires the adoption of election bylaws and agreements for the conduct of local government elections. This report outlines the bylaw requirements for the 2014 election.

## 2.0 Vote 'At Large' and Voting Locations

During the 2011 Election, the City was divided into thirty-five (35) voting divisions establishing the boundaries within which an elector must vote. In 2012 September, Council approved the implementation of the electronic voter strike-off system for the entire election process and authorized the Vote 'At Large' concept for future elections. Staff recommends Council repeal Bylaw No. 12948. This will enable the Vote 'At Large' concept allowing electors to vote where they *live, work, play or learn*.

This action on the part of Council has numerous benefits that will improve the overarching voting experience for electors and is in line with the City's commitment to leadership in social, economic and environmental sustainability.

Staff recommend Council repeal Bylaw No.12948 dividing the City into voting divisions for the purpose of enabling voting 'At Large' at thirty-five (35) voting locations throughout Burnaby as noted in Appendix 'A'.

## **3.0** Advance Voting Opportunities

In 2008, the *Local Government Act* was amended to allow any elector to vote at an Advance Voting Opportunity rather than on general voting day. This resulted in a much larger turnout for advance voting than in previous elections. In 2012, Council approved four additional advance voting locations over three days in each quadrant of the City to provide electors with the option of voting where they *live, work, play or learn*. As a result, advance voting will be held from 8:00 a.m. to 8:00 p.m. at Brentwood Town Centre, Lougheed Town Centre, Metropolis at Metrotown, Edmonds Community Centre and Shadbolt Centre for the Arts.

In accordance with the *Local Government Act*, the City of Burnaby is required to hold at least two Advance Voting Opportunities, one of which must be 10 days prior to general voting day or Wednesday, 2014 November 05. In selecting the extra two (2) advance voting dates for this election, staff referred to voter feedback and past statistics to suggest in addition to November 05, that November 01 and 08 be designated as Advance voting days in 2014.

Staff recommends Council authorize the City Solicitor to prepare a bylaw to provide additional Advance Voting Opportunities on 2014 November 01, and 08.

## 4.0 Special Voting Opportunities (SVO)

Traditionally, Council have also provided Special Voting Opportunities (SVO) for qualified individuals residing in care facilities or seniors' housing or who are hospitalized on voting day.

In 2011, the SVO for seniors' facilities and care homes was held on one weekday prior to general voting day. This was in consideration of requests from the facilities as more staff are available on weekdays to assist qualified voters to attend the voting place within the facilities. This also avoids conflicts with other special events scheduled to take place on the weekends at this time of year. As the feedback was very positive, it is recommended Council continue with this practice and that the date for the SVO be established as Tuesday, 2014 November 04.

Staff recommends Council approve the 2014 local government election Special Voting Opportunities to be held on Tuesday, 2014 November 04 at locations as noted in Appendix 'B' of this report. Voting at Burnaby Hospital will be held on general voting day, 2014 November 15.

## 5.0 Election Day Pay Rates

Election day pay rates, as outlined in *Appendix* 'C' of this report includes compensation for a training allowance and are competitive with other Metro Vancouver municipalities allowing us to continue attracting qualified and experienced staff to carry out election responsibilities.

We have evaluated all staffing requirements and have adjusted the number of staff required at voting locations to address potential increases in the number of eligible voters in neighbourhoods which have experienced significant development and population increases since the last election. Also, as voter turnout at the five (5) voting locations established for the Advance Voting Opportunities is expected to be greater than in 2011, additional staff for the three (3) advance voting dates have been included, particularly for Saturday, 2014 November 01 and 08.

Staff recommends Council approve the 2014 Election Day pay rates as presented in Appendix 'C' attached to this report.

## 6.0 School District No. 41 Cost Sharing Agreement

The *Local Government Act* authorizes the City of Burnaby to enter into an agreement with the School District under which one party conducts its election in conjunction with the election of the other, and further authorizes the sharing of the costs of the election. The Chief Election Officer is seeking authorization from Council to execute an agreement with School District No. 41 to pay the portion of the election costs directly attributed to the election of school trustees, to a maximum of \$10,000.

Staff recommends Council authorize the Chief Election Officer to execute an agreement with School District No. 41 to share in the costs of the 2014 Local Government Election for School Trustees.
