SUBJECT: BURNABY BYLAW NOTICE ENFORCEMENT BYLAW - BYLAW 12657

**PURPOSE:** To seek Council's approval to update the Burnaby Bylaw Notice Enforcement

Bylaw.

### **RECOMMENDATION:**

**1. THAT** Council authorize amendments to the Burnaby Bylaw Notice Enforcement Bylaw – 12657 as outlined in this report.

### **REPORT**

The Burnaby Bylaw Notice Enforcement Bylaw – 12657 was adopted by Council on 2009 June 15. Since the bylaw went in to effect, several bylaw contraventions have been successfully concluded by staff using the enforcement measures.

This report addresses recommended amendments to the Bylaw Notice Enforcement Bylaw – Bylaw 12657 resulting from the adoption and amendments of other bylaws, and the addition of offences from existing bylaws that were not included in the original format. It is also proposes that the list of designated Screening Officers and Bylaw Enforcement Officers be expanded to include additional staff positions.

### 1.0 BYLAW AMENDMENTS

Schedule A of the Bylaw Notice Enforcement Bylaw – Bylaw 12657 lists the sections of each bylaw which can be enforced using a bylaw notice and specifies the fine amounts for each offence. Attachment 1 of this report lists the violation sections and proposed fine amounts for recent amendments to the Burnaby Animal Control Bylaw and the Burnaby Tree Bylaw, the recent adoption of the Burnaby Home Rental Business Licence Bylaw, and additional offences under the Burnaby Building Bylaw and the Burnaby Swimming Pool Enclosure Bylaw. It is recommended that Schedule "A" of the Bylaw Notice Enforcement Bylaw – Bylaw 12657 be amended to incorporate the list of offences contained in Attachment 1.

# 2.0 SCREENING OFFICERS AND BYLAW ENFORCEMENT OFFICERS AMENDMENTS

Before scheduling an adjudication hearing, a Screening Officer is assigned to review each disputed bylaw notice. The Screening Officer's role is to examine all disputed cases and to consider factors such as the likelihood of the notice being successful at adjudication, if a compliance agreement would sufficiently encourage compliance and any other relevant information.

Section 8 of the Bylaw Notice Enforcement Bylaw – Bylaw 12657 designates classes of persons that are appointed as Screening Officers. It is recommended that the title of Director Planning and Building be added to the list of positions appointed as Screening Officers. It is also recommended that the words "Bylaw Enforcement" be removed following the title "Assistant Chief Building Inspector" from item (xvii) of the list.

The Bylaw also specifies the Bylaw Enforcement Officer positions that are authorized to issue bylaw notices. Section 10 of the Bylaw Notice Enforcement Bylaw designates all the positions that are appointed as Bylaw Officers. It is recommended that the position of Landscape Development Technician be added to the list of positions authorize to issue bylaw notices.

## 3.0 **RECOMMENDATIONS**

Since early 2010, the Bylaw Notice Enforcement Program has been successfully used to increase bylaw compliance in Burnaby. To keep the Bylaw Notice Enforcement Bylaw – Bylaw 12657 current with other regulatory bylaws, it is recommended that Council authorize the amendments to Schedule "A" of the Bylaw and to the changes of the Screening Officer and Bylaw Enforcement Officer positions as outlined in this report.
