PURPOSE: To announce the completion of two Electric Vehicle Charging Stations at Deer Lake II 4940 Canada Way, Burnaby.

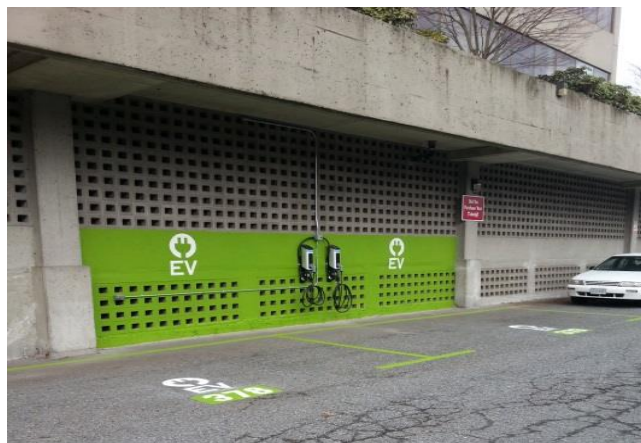
RECOMMENDATIONS:

REPORT

Appearing elsewhere on the Committee's agenda is a report announcing the City's receipt of the Building Owners and Managers Association BEST Awards given in acknowledgement of Go Green Best Practices at Deer Lake I at 4946 Canada Way and Deer Lake II at 4940 Canada Way, Burnaby.

In line with the goal of continuing to enhance environmental sustainability and energy efficiency, two Electric Vehicle Charging Stations have been installed under the Building Owners and Managers Association Clean Connect rebate program. This program provided full reimbursement for the cost of the stations and their installation. This picture shows the stations which are located behind 4940 Canada Way near the entrance/exit of the Deer Lake II Parkade off of Ledger Avenue (see map in Attachment 1).

The charging stations are available for use by drivers of electric vehicles. Two parking stalls at Deer Lake Centre (#378 and #379) accommodate these charging stations. Users charging their vehicle will be required to pay a minimal charge of \$2.00 per hour.

The charging stations will be advertised on the City's website and others such as the Canadian Automobile Association, EV Charging Station network map; the Plug Share – EV Charging Station map and the SEMA charge server map all of which can be viewed either on a computer, tablet or smart phone application. A system wide email will be sent to City staff advising them of the location of this service.

RECOMMENDATIONS

It is recommended that the Environment Committee receive this report for information and that the Committee advise Council of the completion of two Electric Vehicle Charging Stations at Deer Lake Centre 4940 Canada Way, Burnaby.



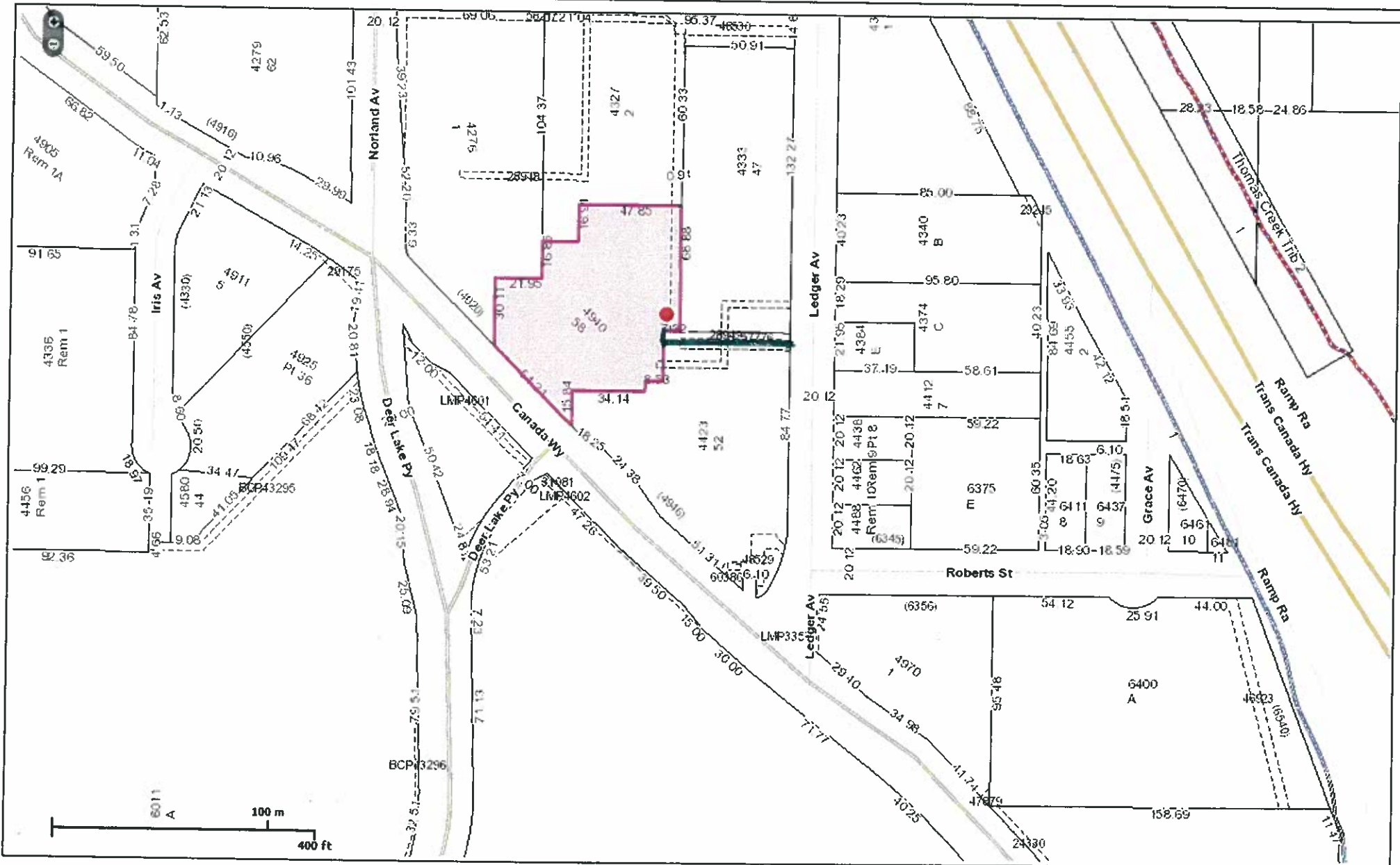
