PURPOSE: To seek approval of donation of proceeds from the RCMP Musical Ride.

REPORT**1.0 BACKGROUND**

The City of Burnaby, RCMP and the three Burnaby Rotary Clubs hosted the 2013 RCMP Musical Ride at Swangard Stadium on August 27, 2013. The sold out event was a great success and attended by over 4200 people. In addition to the RCMP Musical Ride, the event also featured performances by the Robert Malcolm Memorial Pipe Band, CircusWest as well as numerous public safety and crime prevention static displays. Swangard Stadium provided Burnaby residents a tremendous venue to enjoy a unique entertaining evening featuring the RCMP Musical Ride.

2.0 DISCUSSION

As part of the event plan, the net proceeds (ticket revenue less expenses) from the event are to be donated to two charities – the Rotary Club and the Law Enforcement Torch Run. The net proceeds from the event are determined to be \$15,000 which is to be shared by the two aforementioned charities in the amount of \$7,500 each. The Rotary Club has already collected \$1,297 from their 50/50 sales and their remaining share of \$6,203 would be remitted to them subject to Council's approval.

This report is to seek Council's approval of the donation as described above.
