A) David Beattie, Founder and Lead Organizer, Just Say Hello Society appeared before Council advising of a major campaign to erode social isolation in Metro Vancouver including Burnaby. The speaker noted social isolation underpins many other ills which cost all of us financially and in terms of human suffering.

Mr. Beattie noted the Just Say Hello Society uses a logo, a visual marker, as a legitimized and widely-recognized icebreaker that encourages people to talk to each other. This can happen in coffee shops, mall food courts, pubs, restaurants and even buses and the Skytrain. Weather permitting the logo can also be used in many outdoor spaces such as parks, plazas and other urban spaces.

The speaker concluded by thanking Council for the opportunity to increase public awareness of the "Just Say Hello" campaign.

B) Catherine Porter, Pine Ridge Housing Co-operative, appeared before Council expressing appreciation to the City for supporting the Federation of Canadian Municipalities' campaign for affordable housing.

The delegation further advised the Co-operative Housing Federation of BC is currently conducting an associated affordable housing campaign specific to co-operative communities called "You Hold the Key: Fix the Co-op Housing Crunch". Ms. Porter noted most of the federal operating agreements will end between now and 2020. The speaker also noted by 2020, almost 500 co-op households in Burnaby will lose housing charge assistance.

The delegation advised the Co-operative Housing Association of BC continues to work with community partners to convince the provincial government to implement a rent assistance program for low income co-op members.

Ms. Porter concluded by presenting His Worship, Mayor Derek Corrigan with the "Key to the Co-op" and a citation to thank Council for supporting their co-op housing campaign.

C) Mr. Vic Blancard, 4630 Highlawn Drive, Burnaby appeared before Council expressing concern regarding a variety of issues including tax increases, large houses, on-street parking, sister city trips and Brentwood bus loop changes.

This report seeks to formally convey to PMV detailed land use information reflecting Burnaby's adopted land use designations of its port lands in order to provide clarity and definition of the City's long term vision for these lands. Reflecting these local plans and land uses would assist Port Metro Vancouver in the development of a more accurate and consistent Port *Land Use Plan* document.

3. Rezoning Reference #12-18
Riverbend Business Park Conceptual Development Plan
Big Bend Development Plan

The City Manager submitted a report from the Director Planning and Building seeking Council authorization to forward this application to a Public Hearing on 2014 May 27. The purpose of the proposed zoning bylaw amendment is to establish a Conceptual Development Plan for the subject site, which would guide further

individual site specific rezoning applications for the development of a multi-phased industrial business park and riverfront amenity area. No specific development or new construction is being sought under the subject rezoning application.

The City Manager recommended:

- 1. THAT a Rezoning Bylaw be prepared and advanced to First Reading on 2014 May 05, and to a Public Hearing on 2014 May 27 at 7:00 p.m.
- 2. THAT the following be established as prerequisites to the completion of the rezoning:
 - a) The submission of a suitable plan of development.
 - b) The removal of all existing improvements from the site prior to Final Adoption of the Bylaw. Demolition of any improvements will be permitted after Second Reading of the Rezoning Bylaw has been granted, provided that the applicant acknowledges that such permission does not fetter Council's ability to grant or not to grant Third Reading and/or Final Adoption of the Rezoning Bylaw. In addition, the demolition of any improvements will be permitted at any time if they are vacant and considered by staff to be subject to misuse and vandalism.
 - c) The consolidation/subdivision of the net project site.
 - d) The dedication of any rights-of-way deemed requisite.
 - e) The granting of any necessary easements, covenants, and Statutory Rights-of-Way including, but not necessarily limited to:
 - Section 219 Covenant for the retention of identifying existing trees within the riparian setback areas;
 - Section 219 Covenant and Statutory Right-of-Way for the protection and ongoing maintenance of the Fraser River Foreshore and Sturgeon Slough streamside protection and enhancement areas (SPEA);
 - Section 219 Covenant respecting floodproofing requirements;
 - Section 219 Covenant respecting the submitted geotechnical report;
 - Section 219 Covenant restricting development (no build) until a Certificate of Compliance is issued by the Ministry of Environment, by phase of development;
 - Section 219 Covenant restricting all development (no build) until servicing has been achieved and the individual site specific rezoning has been granted Final Adoption;
 - Statutory Rights-of-Way guaranteeing vehicular access across private driveways;
 - Statutory Rights-of-Way guaranteeing pedestrian and cycling access across on-site pathways;
 - Easement guaranteeing reciprocal access for vehicles across property lines; and,

- Section 219 Covenant restricting uses to those permitted within the Conceptual Development Plan.
- f) The submission of a suitable conceptual on-site stormwater management system to the approval of the Director Engineering, and the granting of a Section 219 Covenant to guarantee its provision and continuing operation, with detailed storm water management plans to be required as part of individual site specific rezoning applications.
- g) The approval of a master servicing concept for the site by the Director Engineering.
- h) The pursuance of design guidelines, including a conceptual comprehensive sign plan for the site in accordance with Section 3.7 of this report.
- i) The submission of a Site Profile and resolution of any arising requirements.

4. Rezoning Reference #11-21
Four-Storey Mixed-Use Development
Sixth Street Community Plan

The City Manager submitted a report from the Director Planning and Building seeking Council authorization to forward this application to a Public Hearing on 2014 May 27. The purpose of the proposed zoning bylaw amendment is to permit the construction of a four-storey mixed use development with retail at grade and residential uses above, including surface and underground parking.

The City Manager recommended:

- 1. THAT a Rezoning Bylaw be prepared and advanced to First Reading on 2014 May 05, and to a Public Hearing on 2014 May 27 at 7:00 p.m.
- 2. THAT the following be established as prerequisites to the completion of the rezoning:
 - a) The submission of a suitable plan of development.
 - b) The deposit of sufficient monies including, a 4% Engineering Inspection Fee, to cover the costs of all services necessary to serve the site and the completion of a servicing agreement covering all requisite services. All

services are to be designed to City standards and constructed in accordance with the Engineering Design. One of the conditions for the release of occupancy permits will be the completion of all requisite services.

- c) The installation of all electrical, telephone and cable servicing, and all other wiring underground throughout the development, and to the point of connection to the existing service where sufficient facilities are available to serve the development.
- d) The submission of an undertaking to remove all existing improvements from the site prior to Final Adoption, but not prior to Third Reading of the Bylaw. Demolition of any improvements will be permitted after Second Reading of the Rezoning Bylaw has been granted, provided that the applicant acknowledges that such permission does not fetter Council's ability to grant or not to grant Third Reading and/or Final Adoption of the Rezoning Bylaw. In addition, the demolition of any improvements will be permitted at any time if they are vacant and considered by staff to be subject to misuse and vandalism.
- e) The dedication of any rights-of-way deemed requisite.
- f) The undergrounding of existing overhead wiring abutting the site.
- g) The granting of any necessary statutory rights-of-way, easements and/or covenants.
- h) The granting of any necessary Section 219 Covenants including restricting enclosure of balconies, providing that all disabled parking remain as common property and ensuring compliance with the submitted acoustical analysis.
- i) Compliance with the Council-adopted sound criteria.
- j) The submission of a Comprehensive Sign Plan.
- k) Compliance with the guidelines for underground parking for residential visitors and commercial patrons.
- The provision of a covered car wash stall, and adequately sized and appropriately located garbage handling and recycling material holding space, to the approval of the Director Engineering and a commitment to implement the recycling provisions.
- m) The pursuance of Storm Water Management Best Practices in line with established guidelines.
- n) The submission of a Site Profile and resolution of any arising requirements.

o) The review of a detailed Sediment Control System by the Director Engineering.

- p) The provision of facilities for cyclists in accordance with Section 4.5 of the rezoning report.
- q) The deposit of the applicable Parkland Acquisition Charge.
- r) The deposit of the applicable GVS & DD Sewerage Charge.
- s) The deposit of the applicable School Site Acquisition Charge.
- t) The submission of a written undertaking to distribute area plan notification forms, prepared by the City, with disclosure statements; and, to post area plan notification signs, also prepared by the City, on the development site and in the sales office in prominent and visible locations prior to Third Reading, or at the time marketing for the subject development commences, whichever is first, and remain posted for a period of one year, or until such time that all units are sold, whichever is greater.
