#### **RECOMMENDATIONS:**

- 2. THAT Council be requested to bring down a bylaw to appropriate \$52,335 (inclusive of GST) from Capital Reserves to finance this project.

### REPORT

The 2014-2018 Financial Plan for Parks, Recreation and Cultural Services contains the following project to be funded from Capital Reserves. To enable work to go ahead on this project, approval is requested to bring down a bylaw for funding.

# 1. FOOD SERVICES EQUIPMENT

\$50,000

Equipment at various food service locations throughout the City has received excessive wear and tear due to unforeseen occupancy and increased sales volumes. This requires replacement, repair and upgrades of furniture and equipment related to the food and beverage operation. This funding will allow the Food Services section to maintain service levels. It is expected that additional equipment replacement funding will be required if sales volumes increase as forecast.
