## C) Finance and Civic Development Committee <u>Re:</u> Funding Bylaw – City Buildings

The Finance and Civic Development Committee submitted a report seeking Council funding approval for various City facilities capital projects. The 2014 Provisional Financial Plan includes provision for the City's annual capital program to replace aging building components that have reached the end of their service life. The building program is designed to protect building assets and to maintain the service levels to the occupants of the facilities. By replacing the end of service life components in a timely manner, the City can minimize service disruptions due to system breakdowns.

The Finance and Civic Development Committee recommended:

- 1. THAT Council approve the expenditure of \$4,170,000 from the 2014 Provisional Budget for the projects outlined in this report.
- 2. THAT Council bring down a bylaw to appropriate \$4,378,500 (inclusive of GST) from Capital Reserves to finance the capital projects as described in this report.

#### His Worship, Mayor Derek Corrigan

His Worship, Mayor Derek Corrigan announced that the City of Burnaby has filed an application for intervener status with the National Energy Board regarding the Kinder Morgan Trans Mountain Pipeline Expansion Project. The text of the Mayor's statement is as follows:

"I want to take a few minutes tonight to advise our citizens about the fact that today the City of Burnaby applied for intervener status in the hearings that are part of the National Energy Board public hearing process.

This is in response to our deep concern about the fact that, on December 16, 2013, Kinder Morgan/Trans Mountain submitted an application to the National Energy Board, seeking authorization to build and operate its proposed \$5.4 billion Trans Mountain Expansion Project, which will almost triple oil capacity (from 300,000 to 890,000 barrels per day) in pipelines running to Burnaby from the Alberta oil sands, and bring approximately six times as many tankers per year into Burrard Inlet (up from about 60 to 400) shipping

diluted bitumen from the Westridge Marine Terminal for export. The pipeline would run through Burnaby and will terminate at Kinder Morgan's Westridge Marine Terminal.

The proposed pipeline would carry diluted bitumen (heavy crude oil products) from the Alberta oil sands to Burnaby, for export. Its construction and operation would have tremendous negative impacts on the City. The pipeline would require extensive land disruption for construction and would result in expansion of facilities in Burnaby. Much of the line through our city is proposed to follow new routes that would require new rights-of-way to be constructed. In addition, Kinder Morgan's application proposes expansion of the Burnaby Mountain Terminal (the large round holding tanks that can be seen on the mountain in North Burnaby) from 13 to 26 tanks (more than tripling their storage capacity with larger tanks) and the construction of new loading docks and a utility dock at the Westridge Marine Terminal in Burnaby.

I am extremely concerned about this proposal to build pipelines through Burnaby streets and communities to carry heavy oil from Alberta for export. Trans Mountain says this pipeline is in our best interest. We know that it is not. This is a project that will benefit Trans Mountain at our city's great expense. Putting the Trans Mountain facilities here in the first place, back in 1952, when parkland was expropriated from Burnaby for the Burnaby Mountain tank farm and when the Westridge Terminal was installed on the ecologically sensitive Burrard Inlet waterfront, was an historic mistake. Why would we now exacerbate that error severalfold? And why is Trans Mountain in such a hurry to ship so much of our oil out of our country? Where is the long-term vision here? This is oil our grandchildren will need.

In spite of the fact that this oil is not for us – or for our country, for that matter, our City would be severely impacted by the construction of the new pipelines, then would be perpetually and permanently vulnerable to potential spills – on Burnaby land, near Burnaby homes and in Burrard Inlet. Trans Mountain's application even shows potential spill zones that would see oil flow down Burnaby Mountain into the Brunette River and Burnaby Lake – and even spill zones that would take oil into Burrard Inlet and the Fraser River, all via Burnaby streams and neighbourhoods. This is completely unacceptable and we will do everything we can to ensure this pipeline is not built.

We have already dealt with one significant Trans Mountain spill in our City – in 2007. A Burnaby neighbourhood was drenched in oil, oil leaked into Burrard Inlet and Kask Creek, and 44 homes were oiled, requiring evacuation of families. This was a relatively small spill – in fact miniscule compared to what would be possible with this new pipeline – and was not the diluted bitumen that Trans Mountain is proposing to carry in the new lines. In spite of safety assurances from Kinder Morgan and Trans Mountain, in Burnaby we know what can and really does happen with pipelines and we will not stand idly by while Trans Mountain proposes to further increase our City's risk.

Burnaby groups and citizens can independently apply to participate in the National Energy Board hearings online through the National Energy Board's website. You can also contact the NEB at 1-866-514-6700 or ask to be added to an email list that provides

updates on the hearing process. All applications for participation must be received by the NEB by 11 a.m., Pacific time, February 12.

Regardless of whether or not you formally apply to participate in the hearings, we hope that you will work with us to make Burnaby citizens' voices heard throughout the hearing process! To help ensure you will be heard and to help you to become familiar with Kinder Morgan/Trans Mountain's proposal and the tremendous threats it poses, the City will host a number of information sessions and will post information on the City website. Two public workshops will take place in the near future in the City, to offer residents and businesses information about the proposed expansion and how they can express their views.

The Trans Mountain application is 15,000 pages long, so we all need some help getting through it. But it is worth our time. It talks about how the line will travel through what the application itself describes as "the rich agricultural lands of the Lower Mainland of B.C." and makes reassuring comments (in a section on economic impacts) such as –and I really can't get over this one – "Spill response and clean-up creates business and employment opportunities for affected communities, regions, and clean-up service providers." End quote.

So, when you hear Kinder Morgan talking about the economic benefits of this project, it's important to note the sorts of activities they count as a benefit! In Burnaby, spill clean-up is not an employment sector we are looking to expand.

In closing, this proposal is absurd. We will work hard to fight it and to help Burnaby businesses and citizens to become aware of all of its potential implications – and we hope that all of you will join us in this very important fight to protect our community and our environment."
