PRESENTATION

Youth Citizenship Awards <u>Presenter:</u> His Worship, Mayor Derek Corrigan

Certificate of Recognition Recipients and Award Winners

His Worship, Mayor Derek Corrigan introduced Youth Week, an annual event to celebrate and acknowledge the contributions of young people to the community. Following is the text of the Mayor's remarks:

"20 years ago, youth across the lower mainland asked why there wasn't a day to celebrate youth. Then asked why not a week rather than a day. This simple idea is what started it all. Youth Week is now an international celebration. Here in British Columbia, youth week takes place during the first week of May and is a fun filled week of interaction and celebration intending to build a strong connection between young people and their communities and to profile the issues, accomplishments and diversity of youth.

Wherever Youth Week is celebrated, the idea behind it is the same: Young people are important and need to be recognized in a constructive and positive manner. Their contributions need to be acknowledged and celebrated. There are a number of Burnaby Board of Education Trustees here tonight to celebrate the accomplishments of our youth and to show their support:

Youth are often criticized and stereotyped and this year's group will prove otherwise. These youth have faced adversity and overcome so much, not to mention all the extra work they do to help. Those in attendance today are youth who volunteer at youth and recreation centres; lead girls groups, focusing on bullying and self-esteem; organize volunteer programs and work with students with special needs; are involved in leadership groups organizing events in the community; part of green/eco teams; organize technology training for seniors. This is just a brief summation of all the fine work that these youth present are achieving and some of the reasons why they have been nominated for this award.

A) Community Development Committee Re: R12S District Area Rezoning Public Consultation Results – Area Bounded by Neville Street, Curragh Avenue, Clinton Street and Buller Avenue

The Community Development Committee submitted a report to Council reviewing the results of the consultation process regarding a request for an area rezoning from the R5 and R9 Residential Districts to the R12S Residential District. Of the 28 property owners in the rezoning area, 16 indicated support, 2 objected and 10 did not respond. As such, the proposal has reached the required percentage of support under the City's adopted guidelines for the Area Rezoning program.

The Community Development Committee recommended:

- 1. THAT Council authorize a Rezoning Bylaw for the area bounded by Neville Street, Curragh Avenue, Clinton Street, and Buller Avenue, as referenced in *Schedule A*, be prepared and advanced to First Reading on 2014 June 9 and to Public Hearing on 2014 June 24 at 7:00 p.m. to rezone the subject properties from the R5 and R9 Residential Districts to the R12S Residential District.
- 2. THAT a copy of this report be sent to the property owners and residents in the petition and consultation areas, as shown on *Attachment #1*.

- 2. THAT Council authorize staff to bring down a Capital Reserve Expenditure Bylaw for the amount of \$4,090,000, as outlined in this report.

The general contractor is maintaining the original construction schedule which indicates substantial completion by the end of August 2014. The work site is well organized and work to date is of a good standard. Staff will continue to monitor progress and provide updated reports throughout the course of construction.

1. <u>Bill C-23 – Fair Election Act</u>

The City Manager submitted a report from the Director Planning and Building regarding the provisions of the Federal government's Fair Elections Act. In considering the downward trend in voter turnout for federal, provincial and municipal elections, staff noted it is imperative that voters perceive the electoral process to be fair, transparent and accountable. Bill C-23, including recent amendments, undermines these three key elements and could potentially further the trend in low voter turnout at all levels of government. On this basis, and given

the outstanding concerns regarding the proposed legislation, staff advised it would be appropriate for Council to request the Federal government to withdraw the bill and draft a new electoral bill developed through meaningful consultation with the Canadian public, opposition parties, and electoral experts.

The City Manager recommended:

- 1. THAT Council write to Minister of State Paul Poilievre to express its concerns with Bill C-23 and to urge the Minister to withdraw the bill.
- 2. THAT Council request the Minister to draft a new electoral bill based on meaningful consultation with the Canadian public, opposition parties and electoral experts.
- 3. THAT a copy of this report be sent to Burnaby's Members of Parliament and Members of the Legislative Assembly.

2. Rezoning Reference #12-48 Proposed Two-Phase Rezoning for a Residential Sales Centre and one-Storey Commercial Building

The City Manager submitted a report from the Director Planning and Building seeking Council authorization to forward this application to a Public Hearing on 2014 May 27. The purpose of the proposed zoning bylaw amendment is to permit the construction of a one-storey commercial building once the residential sales centre use ceases.

The City Manager recommended:

- 1. THAT a Rezoning Bylaw be prepared and advanced to First Reading on 2014 May 05, and to a Public Hearing on 2014 May 27 at 7:00 p.m.
- 2. THAT the predecessor Rezoning Bylaw, Amendment Bylaw No. 27/2013, Bylaw #13237, be abandoned contingent upon the granting by Council of Second Reading of the subject rezoning bylaw.
- 3. THAT the following be established as prerequisites to the completion of the rezoning:
 - a) The submission of a suitable plan for each phase of development.

- b) The deposit of sufficient monies including a 4% Engineering Inspection Fee to cover the costs of all services necessary to serve the site and the completion of a servicing agreement covering all requisite services. All services are to be designed to City standards and constructed in accordance with the Engineering Design. One of the conditions for the release of occupancy permits will be the completion of all requisite services.
- c) The installation of all electrical, telephone and cable servicing, and all other wiring underground throughout the development, and to the point of connection to the existing service where sufficient facilities are available to serve the development.
- d) The undergrounding of existing overhead wiring abutting the site on Waverley Avenue, and pre-ducting with a cash deposit for future undergrounding of overhead wiring abutting the site along Imperial Street.
- e) The dedication of any rights-of-way deemed requisite.
- f) The review of a detailed Sediment Control System by the Director Engineering.
- g) The pursuance of Storm Water Management Best Practices in line with established guidelines.
- h) The submission of a Site Profile and resolution of any arising requirements.
- i) The submission of a detailed Comprehensive Sign Plan.
- j) The deposit of the applicable GVS & DD Sewerage Charge.

These works are fully funded by TransLink and include improvements to drainage culverts, streetlights, fences, concrete curbs, sidewalks and medians at various locations on the MRN. However, the City must interim finance these expenditures as payment transfers from TransLink are made on a quarterly basis.

The City Manager recommended:

1. THAT Council authorize the expenditure of \$140,000 included in the 2014 Provisional Plan within the General Capital Replacement Reserves to finance the capital projects as described in this report.
