At the conclusion of the 'Closed' meeting, the 'Open' meeting was reconvened at 7:00 p.m. in the Council Chamber.

IN MEMORIAM

Mr. Nuburi Toko

His Worship, Mayor Derek Corrigan announced the recent passing of Mr. Noburi Toko, a renowned Japanese sculptor. Mr. Toko and his son created the 'Playground of the Gods' sculpture located on Burnaby Mountain. This work of art commemorates the goodwill between Burnaby and its sister city, Kushiro, Japan.

On behalf of Council and the citizens of Burnaby, Mayor Corrigan expressed sincere condolences to Mr. Toko's family and the City of Kushiro.

PROCLAMATIONS

His Worship, Mayor Derek Corrigan proclaimed 2015 as "The Year of Women in Sport" in the City of Burnaby.

Mayor Corrigan presented a framed copy of the proclamation to Linda Diano, a representative from "The Power in Sport".

Ms. Diano provided Council with copies of a document containing comments from citizens in support of the proclamation.

Councillor Dhaliwal, on behalf of His Worship, Mayor Derek Corrigan proclaimed October as "Foster Family Month" in the City of Burnaby.

Councillor McDonell, on behalf of His Worship, Mayor Derek Corrigan proclaimed October 12th to 18th as "Homelessness Action Week" in the City of Burnaby.

Councillor Volkow, on behalf of His Worship, Mayor Derek Corrigan proclaimed October 16th as "New Vista Society Day" in the City of Burnaby.

Councillor Kang, on behalf of His Worship, Mayor Derek Corrigan proclaimed October 10th as "World Mental Health Day" in the City of Burnaby.

PRESENTATIONS

Safe Work Environment Sergio Picco, Manager, Occupational Health, Safety, RTW

Sergio Picco, Manager, Occupational Health and Safety, provided an overview of the City of Burnaby Certificate of Recognition (COR) Program. The program is a partnership between the City of Burnaby, WorkSafeBC, and the certifying partner BC Municipal Safety Association (BCMSA). The program recognizes the City of Burnaby for going above and beyond mere compliance with Occupational Health and Safety regulations and Return to Work programs.

The speaker outlined the benefits of COR certification including those noted below:

- Improved standards in occupational health and safety for the City
- Annual WorkSafeBC rebates
- Reduced claim durations; anticipated decrease in WorkSafeBC Assessment Premiums in future years.

Mr. Picco noted in 2013 the number of days lost declined by 35%. In 2014, this figure is projected to decrease a further 6%, The speaker concluded by expressing appreciation to Mayor Corrigan and Council for their support and commitment to safety.

Environmental Sustainability Strategy David Clutton, Long Range Planner

David Clutton, Long Range Planner, provided an overview of the Environmental Sustainability Strategy (ESS) and noted the following points:

- The purpose of the strategy is to set directions for environmental protection, stewardship, enhancement and resilience in the City of Burnaby
- The ESS Steering Committee, a group of recognized leaders from the community representing diverse backgrounds and interests, is guiding the creation of the strategy; the Chair of the Steering Committee is Mayor Derek Corrigan
- The strategy is structured around 10 themes as noted below:
 - Live land use planning and development
 - Move transportation
 - Green green space and habitat
 - Build green buildings and energy
 - Flow water management
 - Conserve waste management
 - Nourish food systems
 - Breathe climate and air quality
 - Prosper green and inclusive economy
 - Manage governance, education and partnerships

Mr. Clutton advised that two of the three public consultation phases for the ESS have been completed. Over 2,100 people have participated in the consultation process to date.

The speaker concluded by noting phase three of the public consultation process will begin early next year and it is anticipated the strategy will be finalized and forwarded to Council for approval in the spring of 2015.

Medical Calls Response Doug McDonald, Fire Chief

Doug McDonald, Fire Chief, and Joe Robertson, Deputy Fire Chief Administration, provided an overview of amendments to the Resource Allocation Plan (RAP) by BC Emergency Health Services (BCEHS) and the impact of those changes on Burnaby citizens and the service provided by the Fire Department.

Councillor Chang retired from the 'Open' Council meeting at 8:10 p.m.

The speakers noted the amendments mandated a reduction in response level from the BC Ambulance Service (BCAS) for 74 types of medical emergencies. The speakers further noted these reduced response levels have negatively impacted Burnaby citizens and fire department resources.

Councillor Chang returned to the 'Open' Council meeting at 8:22 p.m. and took his place at the Council table.

Chief McDonald and Deputy Chief Robertson also noted the following points:

- There is no evidence that response to medical incidents by the Burnaby Fire Department cause a danger on the roads
- BCEHS claims the changes to RAP have saved up to 1 minute for response to urgent cases; in Burnaby it is only 20 seconds

The speakers concluded by noting that even though BCEHS has reduced its service to the public by reducing the number of calls that medically require a Code 3 lights and sirens response, the Burnaby Fire Department remains committed to responding to emergency medical calls in a timely manner.

Councillor Dhaliwal retired from the 'Open' Council meeting at 8:42 p.m.
