#### CARRIED UNANIMOUSLY

A) Ms. Anne Waller, Administrator and Ms. Michele Wilson, Coordinator Community Volunteer Resources, Citizen Support Services, appeared before Council to present their 2013 Annual Report. The delegation noted the number of residents utilizing their programs for seniors and children increased in 2013. The delegation advised that Citizen Support Services is the lead agency for the Burnaby Better at Home Program, funded by the provincial government and managed by the United Way. This program assists seniors with simple daily non-medical tasks to allow them to stay at home and keep living independently. The Burnaby Program offers light housekeeping and rides to medical appointments based on a sliding scale of payment, dependent on income.

The delegation concluded by expressing appreciation to city staff, community volunteers and Council for their support.

**B)** Mariam Larson, Coordinator, and David La Croix, Chair, Voices of Burnaby Seniors (VOBS), 323 E. Sixth Avenue, New Westminster, appeared before Council to highlight their recent successes and current projects.

The delegation noted the following points:

- VOBS has been involved in a variety of successful projects including the Burnaby Neighbourhood House Senior Ambassador Program, community resource cards and agency networking events.
- VOBS worked with TransLink to develop and deliver a program called Travel Smart for Seniors. The program has helped seniors feel capable, safe and confident when using the transit system.
- VOBS supported the Burnaby Fall Prevention Society in bringing the Fraser Health Safety Superheroes Fall Prevention initiative to 1600 Burnaby seniors.
- VOBS helped develop and participated in City initiatives such as accessibility audits in the Edmonds and Cascade Heights neighbourhoods as well as community consultations on housing, transportation, food security and sustainability strategies.
- United Way funding for the VOBS coordinator position will end in June 2014.

The delegation concluded by thanking Council for supporting their organization by providing meeting space as well as assistance from City staff.

Arising from discussion of the delegation's presentation, His Worship, Mayor Derek Corrigan advised that he would send a letter to the United Way requesting continued funding for VOBS.

C) Craig Richmond, President and CEO, Anne Murray, Vice President, Community & Environmental Affairs, Vancouver Airport Authority, appeared before Council to report on the Authority's initiatives and activities.

The delegation noted the following points:

• YVR set a new record of 17.97 million passengers in 2013; growth was led by increased service to China as well as increases in intra – BC regional services.

- Construction of the designer outlet centre is underway with completion of both Phase One and Two slated for the spring of 2015.
- In April 2013, Vancouver International Airport successfully carried out the largest emergency planning exercise in YVR's history involving over 780 individuals and 30 agencies.
- In 2013, Vancouver Airport Authority completed the new 2014 18 Noise Management Plan including a five year action agenda.

The delegation noted YVR's mandate includes contributing to BC's economy by generating jobs, facilitating trade and tourism and creating opportunity for BC businesses. The speakers also advised the Airport Authority is working with governments and like-minded organizations to open up service treaties with other countries allowing more service to YVR. In addition, the delegation noted another major policy thrust involves removing barriers to trade by simplifying Canada's visa process; including allowing more countries and airlines to participate in the program that allows connecting passengers to travel via YVR without a visa.

The speakers concluded by requesting the City of Burnaby continue to support the efforts of the Airport Authority to increase their business.
