## COUNCIL REPORT

**SOUTH AND CENTRAL BURNABY**  
**ROAD REHABILITATION PROGRAM**

**PURPOSE:** To obtain Council approval to award a contract for the South and Central Burnaby Road Rehabilitation Program.

**RECOMMENDATION:**

1. **THAT** Council approve a contract award to Winvan Paving Ltd. for an estimated total cost of \$3,254,583.83 including GST in the amount of \$154,980.18 as outlined in this report. Final payment will be based on the actual quantity of goods and services delivered and unit prices as tendered.

**REPORT**

Four tenders ranging from \$3,254,583.83 to \$3,651,350.85 were received by the closing time on 2017 February 23. The scope of this project includes asphalt paving of local roads, accessibility improvements to concrete sidewalk and urban trails, and installation of communication conduit in the following locations:

**Road Rehabilitation:**

- Gordon Avenue: Imperial Street to Formby Street
- Mayfield Street: Gordon Avenue to Canada Way
- Formby Street: Gordon Avenue to Canada Way
- Nelson Avenue: Dover Street to Kingsway
- Hazel Street: McMurray Avenue to Nelson Avenue
- Newton Street: Nelson Street to Marlborough Street
- Bainbridge Avenue: Lougheed Highway to Greenwood Street
- Hazelmere Street: Canada Way to cul-de-sac
- Innsmoor Place: Reigate Road to cul-de-sac
- Alberly Place: Reigate Road to cul-de-sac
- Berkley Place: Reigate Road to cul-de-sac
- Wickham Place: cul-de-sac west of Berkley Street
- Leeds Court: cul-de-sac east of Berkley Street
- Berkley Street: 6<sup>th</sup> Street to Reigate Road
- Reigate Road: 6<sup>th</sup> Street to Lakefield Drive
- Welsley Drive: Morley Street to 6<sup>th</sup> Street
- Morley Street: Canada Way to cul-de-sac east of Varley Street

- Varley Street: Welsley Drive to Morley Street
- 7<sup>th</sup> Street: Morley Street to Berkley Street
- Lane Street: Royal Oak Avenue to Kingsway
- Macpherson Avenue: Kingsway to Imperial Street
- Frances Street: Grove Avenue to Sperling Avenue
- Byrnespark Drive: Southwynde Avenue to Sperling Avenue

Bus Stop Improvements:

- Walker Avenue: Bus Stop south of Stanley Street

Urban Trail / Sidewalk Improvements

- North Fraser Way: Boundary Road to Fraserton Court
- Glen Lyon Parkway: North Fraser Way to CPR Tracks

IT Communication Conduit:

- Nelson Avenue: Dover Street to Kingsway

The lowest tenderer Winvan Paving Ltd. has completed previous projects under contract to the satisfaction of the City. Review by City staff and our consultant indicates the contractor has the equipment and personnel capability to successfully complete the work required under this contract. The Director Engineering concurs with the above recommendation.

This capital work is provided for within the 2017-2021 Provisional Financial Plan under the following WBS elements: AEC.0015 (\$115,000.00), EMC.0011 (\$2,647,500.00), EMD.0024 (\$258,000.00) and EMF.0054 (\$36,100.00). Contingency funding in the amount of \$45,197.25, including GST in the amount of \$2,152.25, has also been sought from the City Manager to complete the IT Communications Conduit portion under the following WBS element: AEC.0015 (\$43,000.00).

Approval of this contract award is subject to the final adoption of Bylaw No. 13727 which appears elsewhere on this agenda.
