**SUBJECT: CONTRACT EXTENSION
SUPPLY AND INSTALLATION OF HOLIDAY LIGHTS AND
DECORATIONS**

PURPOSE: To obtain Council approval for a one year contract extension for the supply and installation of holiday lights and decorations.

RECOMMENDATION:

- 1. THAT** Council approve a one year contract extension to White Raven Enterprises Inc. doing business as Festilight Vancouver for the value of \$413,693.00 including GST and PST in the amount of \$44,324.25.

REPORT

In 2016 August, the City issued a Request for Proposal (RFP) for the supply and installation of holiday lights and decorations. Festilight Vancouver was awarded a contract for a one year term from 2016 October 01 to 2017 September 30, at a cost of \$191,172.57, including GST and PST in the amount of \$20,482.78, with options for up to four individual one year extensions at the discretion of the City.

In 2017 September, Festilight Vancouver was awarded the first one year extension from 2017 October 01 to 2018 September 30, at a cost of \$73,815.84, including GST and PST in the amount of \$7,908.84. A further increase to the contract in the amount of \$201,967.10, including GST and PST in the amount of \$21,639.33, was required to address additional lighting requirements in quantity and locations as well as the removal of the lights for the 2017/2018 term.

Festilight Vancouver has successfully completed the work under the contract for the last two years. The second extension would cover any new installation, reinstallation, maintenance and removal of holiday lights at various locations for the 2018/19 term. City staff's review has found the Contractor's pricing to be competitive and reflective of current market conditions.

It is recommended that a second one year contract extension from 2018 October 01 to 2019 September 30 be awarded at a cost of \$413,693.00 including GST and PST in the amount of \$44,324.25. This amount also includes the additional scope for lighting along Hastings Street. The total contract value for this contract over the three years is now estimated at \$880,648.51, including GST and PST in the amount of \$94,355.20.
