SUBJECT: **COMMUNITY EMERGENCY PREPAREDNESS APPLICATION
EMERGENCY OPERATIONS CENTRES AND TRAINING**

PURPOSE: To request approval to submit an UBCM application for the Provincial Community Emergency Preparedness Fund (CEPF) – Emergency Operations Centres and Training funding stream.

RECOMMENDATION:

1. **THAT** Committee recommend to Council that staff be authorized to submit an UBCM funding application as outlined in this report.

REPORT**1.0 BACKGROUND**

The 2016 Provincial Budget established an \$80 million Community Emergency Preparedness Fund (CEPF) administered by the Union of BC Municipalities (UBCM) that includes funding for Emergency Operations Centres & Training. Approved applications can be funded to a maximum of \$25,000. The application deadline is February 2, 2018 and must include a Council resolution. Staff propose submitting the following projects for funding:

- Conference Phone System (Budget: \$4,000)
Acquisition of a conference phone system for the EOC Breakout Room.
- EOC Tables with power/data ports (Budget: \$21,000)
Acquisition of Trapeza Collaboration Tables for the EOC Main Room.

The proposed application for funding outlined in this report contributes to the Corporate Strategic Plan by:


