**PURPOSE:** To obtain Council approval to change the Routine Transaction Authority Bylaw to increase to the City's Manager's spend and approval limits.

# **RECOMMENDATIONS:**

- 1. **THAT** the Financial Management Committee recommend Council approve an increase to the City Manager's authority to approve an award of contract and execute legal agreements for procurement of municipal goods, services and construction where the authorized level does not exceed \$1,000,000.
- 2. **THAT** the Financial Management Committee recommend Council authorize the City Solicitor to prepare a bylaw amendment to the Burnaby Routine Transaction Authority Bylaw 1999 to implement the proposed spend and approval limits increase for the City Manager.

# REPORT

# 1.0 INTRODUCTION

The Burnaby Routine Transaction Authority Bylaw 1999 delegates the power to authorize certain routine transactions to certain officers and employees of the City to support administrative efficiency and effectiveness.

On 2020 March 27, Council authorized a temporary increase to the City Manager's authority to approve an award of contract and execute legal agreements for procurement of municipal goods, services and construction where the authorized level does not exceed \$1,000,000 (previously \$500,000), for a period of six months, through a temporary bylaw amendment. On 2020 September 14, Council authorized, through another temporary bylaw amendment, a second temporary increase to the City Manager's authority for an additional six months. The current bylaw amendment expires on 2021 March 28.

During the period 2020 March 27 to 2021 February 01, the City Manager has approved a total of 28 transactions exceeding \$500,000 including contract increases, contract extensions and new contracts with values approved ranging between \$247,161.60 and \$870,570.08. These contracts are all routine contracts for goods and services utilized by the City. The list of contract approvals are reflected in Attachment 1.

Due to the relatively small number of transactions over the past year and the routine nature of the transactions between \$500,000 and \$1,000,000, as well as the ability for the City to be responsive to the changing needs for goods, services and supplies on an ongoing basis, it is proposed that the spend and approval authorization limits for the City Manager be permanently changed to \$1,000,000 from the date of adoption of the bylaw amendment implementing the change. The bylaw amendment is needed to provide the City Manager appropriate approval authority on an ongoing basis to address needs for goods, services and supplies necessary for the City's operations.

# 3.0 BYLAW AMENDMENTS

It is recommended that the City Solicitor be authorized to prepare a bylaw amendment to permanently change Section 2(a1) of the Burnaby Routine Transaction Bylaw 1999 to increase the spend and approval limits for the City Manager to \$1,000,000. If the Financial Management Committee agrees with this recommendation, this report will be brought forward to the 2021 February 22 Council meeting, together with the amendment bylaw for 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> readings and then final adoption at the 2021 March 8 meeting. Upon final adoption of the amendment bylaw, the City Manager's spend and approval limits will be increased to \$1,000,000 going forward.

It is proposed that Section 2(a1) of the Burnaby Routine Transaction Bylaw 1999 be amended to read as follows on a permanent basis:

(a1) to each of the positions listed below, the authority to approve for award of contract by the City's Purchasing Manager and execute legal agreements for procurement of municipal goods, services and construction where the authorized level does not exceed the amount shown in the table below:

### 4.0 **RECOMMENDATION**

It is recommended that the Financial Management Committee recommend Council approve the increase to the spend and approval authorization limits of the City Manager permanently to \$1,000,000, and authorize the City Solicitor to prepare a bylaw amendment to the Burnaby Routine Transaction Authority Bylaw 1999 as outlined in this report.
