**FUNDING REQUEST** 

**PURPOSE:** To request a Capital Reserve Fund Bylaw to finance 2021 Engineering capital

transportation projects.

#### **REPORT**

#### INTRODUCTION

The 2021 - 2025 Provisional Financial Plan will provide funding for various multi-year capital improvement projects. Upon approval of this funding request by Council, these expenditures will be included in the 2021 - 2025 Provisional Financial Plan (Engineering Section). In order to proceed with the award of contracts for design, contract administration and construction, funding approval is requested for the projects listed below. This report is to seek Council approval of fund allocation for Engineering projects in advance of Council adoption of the 2021 - 2025 Provisional Financial Plan.

### 1. Transportation

### 1.0 Traffic Management Centre

EMF.0095

Estimated \$200,000

This project creates a Traffic Management Centre to collect and assess traffic data, monitor traffic conditions in real time, improve response time to incidents, allow remote adjustments of signal timings and manage construction activities. Tools, equipment, components, and resources for the Traffic Management Centre are being implemented gradually. Additional remote cameras will be implemented and permanent traffic data collection stations will be setup for speed, volume measurement and vehicle size classifications.

#### 1.1 Bus Shelter Program

Estimated \$100,000

This program continues the installation of new or the replacement of older bus shelters throughout Burnaby. New bus shelter installations improve amenities for transit users, increase revenues with their advertising panels, and increase operating/maintenance costs. 10 new shelters are anticipated to be purchased and installed at priority locations.

### 1.2 Safety Improvements

EMF.0094

**Estimated \$100,000** 

This project will add left turn lanes at the 10<sup>th</sup> Avenue and Canada Way intersection along all four legs to improve traffic safety. Design will commence in 2021 and some land acquisition will be required to perform the work. Funding is being requested for design only and additional funding approval will be submitted in the future for construction. This project is also expected to receive funding contributions from TransLink, ICBC and the City of New Westminster.

## 1.3 Minor Traffic Management Projects EMF.0093

Estimated \$400,000

This program funds a variety of minor traffic management projects to enhance safety or traffic operations. Projects include traffic calming devices such as medians, curb bulges and flashing beacons at crosswalks. Proposed projects include traffic calming measures along Elwell Street, Southpoint Drive and Beresford Street. Funding contributions are expected from ICBC.

# 1.4 Streetlight Pole Replacement

Estimated \$654,100

This program replaces streetlight poles along the Major Road Network (MRN) and Local Road Network (LRN) that are beyond their useful life or damaged. This program ensures the poles are structurally sound and may include the replacement of pole bases if required. Identifying and replacing aging street light poles will mitigate the risk to the general public and also allow for the opportunity to update existing inventory to contain the latest attributes for future tracking purposes.
