### SUBJECT: BURNABY ARTS COUNCIL OPERATING GRANT

**PURPOSE:** To provide information and seek approval regarding the Burnaby Arts Council operating funding contribution for the 2024 fiscal year.

#### RECOMMENDATION

**THAT** an operating contribution of \$25,000 be awarded to the Burnaby Arts Council for the 2024 fiscal year; and

**THAT** the Burnaby Arts Council be approved to operate and profit from the proceeds of a properly licensed 50/50 draw or raffle at the City's summer music festival on August 10, 2024.

## 1.0 POLICY SECTION

City support for the Burnaby Arts Council (BAC) is aligned with the following Counciladopted policies, plans and strategies: The *Burnaby Economic Development* Strategy (2007), the *Social Sustainability Strategy* (2011), *the Benefits Based Approach* (2023) and the *Corporate Strategic Plan* (2017).

# 2.0 BACKGROUND

The BAC continues to make meaningful contributions to the arts in Burnaby with a focus on supporting and providing an environment for young and emerging artists. They have also expanded their ways of supporting member groups, artists and art enthusiasts for the community.

Since 2000, the City has supported BAC with operating funding and access to a facility that is owned and maintained by the City. The City's contribution provides stability and service continuity while leveraging additional partnerships and funding to support BAC services and programs.

#### 3.0 GENERAL INFORMATION

The BAC is a non-profit and charitable organization which has operated in Burnaby since 1967, with a mandate to promote, support and expand the arts. BAC currently has a volunteer working board, one full-time administrator, part-time programming assistants and a membership of over 140 individuals and 20 member groups. It operates the Deer Lake Gallery in Deer Lake Park and provides a variety of programs and services,

including monthly community arts exhibitions and special events. It is a unique nonprofit arts organization in Burnaby.

The City has historically provided support to the BAC due to the strong alignment between both organizations in cultural priorities. City support for the BAC expands cultural activity in Burnaby for emerging and early career artists and ensures that artist development and support is occurring at a grassroots level in addition to the complementary professional programming at the Burnaby Art Gallery and Shadbolt Centre for the Arts. The BAC estimates that 80% of its audience and program participants are Burnaby residents.

This year, the BAC has requested \$25,000, consistent with its annual request since 2000. This represents approximately 13% of the organization's provisional budget for 2024. The applicant has advised that increasing program expenses has placed significant pressure on earned and raised revenues. BAC is interested in exploring a potential increase in operating support from the City in advance of 2025 budget discussions.

In addition to the operating grant, the BAC has also asked for consideration of running a 50/50 draw or raffle at a City summer music festival to raise funds to contribute towards the organization's financial sustainability. This request is compatible with the festival and can be accommodated, if approved.

The Burnaby Arts Council has traditionally received support from senior levels of government through the BC Arts Council (BCAC) and BC Gaming. A new grant from United Way foundation this year helped them to expand their reach and programming such as the new temporary public murals on the building. Other revenue sources include memberships, individual contributions, donations, raffles, sponsorships and program fees/admissions.
