The purpose of the proposed zoning bylaw amendment is to permit the construction of an open air kitchen area for the existing Burnaby mosque.

The Advisory Planning Commission advised it supports the rezoning application.

An email was received from <u>Dana Bailey</u>, 5128 Wilton Avenue, Burnaby opposing the rezoning application. The writer noted the proposed outdoor kitchen will result in additional garbage and attract rodents, coyotes, and small animals. The writer also expressed concern regarding food odours, foot traffic, vehicle traffic, and parking.

An email was received from <u>Linda Jung</u> noting she is not in favour of the rezoning application. The writer expressed concern regarding odours, garbage, vehicle traffic and parking.

<u>Deborah Baxter</u>, 7739 McCarthy Court, Burnaby appeared before Council opposing the rezoning application. The speaker expressed concern regarding odours from the outdoor kitchen, increased traffic and parking on neighbourhood streets.

<u>Sharif Senbel</u>, Studio Senbel Architecture & Design, 2-548 Victoria Drive, Vancouver, the rezoning applicant, appeared before Council advising that the outdoor kitchen will not increase the number of programs or services provided by the mosque. Mr. Senbel also noted that kitchen exhaust will be treated through a commercial vent hood to minimize odour impacts to adjacent areas.

His Worship, Mayor Derek R. Corrigan, noted the importance of good neighbour policies and requested that the rezoning applicant work with the mosque to address neighbourhood concerns.

<u>Jack Lee</u>, 4951 Claude Avenue, Burnaby appeared before Council expressing concern regarding the rezoning application. The speaker noted that overflowing garbage bin attracts rodents. The speaker also advised that visitors to the mosque park in front of his driveway.

There were no further submissions received regarding Rezoning #13-04, Bylaw No. 13197.
